NATURAL SELECTIONS TOURS TERMS & CONDITIONS

TOUR PAYMENTS: All payments, including initial deposit, can be made by check, credit card, or wire transfer. Unless otherwise stated in the tour flyer & description, full payment is due 120 days prior to departure.

CANCELLATIONS – Initial deposits are non-refundable. Initial deposits may be transferable to other Natural Selections tours if those tours have space available and are beginning less than 12 months from the date of the original tour. For cancellations made 180 days or more before the tour departure date, 50% of payments made will be refunded, less a cancellation fee **of** \$500. For cancellations made between 179 and 151 days before departure date, 25% of any payments made will be refunded less a cancellation fee **of** \$500. If cancellation is made fewer than 150 days before departure date, no refund is available. This policy and fee schedule also applies to pre- and post-tour extensions. It is necessary to make your payments on time and according to the payment schedule to retain your space on a tour. We highly recommend that you purchase trip cancellation (including medical emergency) insurance to cover your investment in case of cancellation, injury or illness to you or a family member prior to or during a trip.
